NEWSPAPER HIGHLIGHT

A team of Jordanian and French archaeologists said on Tuesday that it had found a roughly 9,000 year old shrine at a remote Neolithic site in Jordan's eastern desert. The ritual complex was found in a Neolithic campsite near large structures known as "desert kites," or mass traps that are believed to have been used to corral wild gazelles for slaughter. Such traps consist of two or more long stone walls converging toward an enclosure and are found scattered across the deserts of the West Asia. "The site is unique, first because of its preservation state.

Welcoming India's "independent" stand at the UN Security Council on Moscow's moves in eastern Ukraine, Russia's Acting Ambassador to India, Roman Babushkin, said that the new sanctions imposed on his would not affect country delivery of the S400 missile system and other defence equipment that India had purchased from Russia. He stressed that the ongoing visit by Pakistan Prime Minister Imran Khan to Moscow would in no way affect India-Russia ties, adding that the Pakistan-Russia partnership does not envisage a defence relationship at present, and Russia stands firm on its policy that Kashmir is a bilateral dispute.

The second wave of the pandemic in India, when a national lockdown was not imposed as during the first, failed to significantly alleviate economic distress hunger among the poor. The survey, Hunger Watch2, was commissioned by the Right to Food Campaign and the Centre for Equity Studies during December 2021 and January 2022 to evaluate economic distress following wave. The second organisations conducted Hunger Watch1 from October to December in 2020 to measure the fallout of the first wave. As much as 66% of the respondents of the second survey said their incomes had decreased from the pre-pandemic level.

- **1.**An FIR has been registered against three Mumbai Police officials for allegedly threatening Angadias and extorting money from them in south Mumbai. The Angadia system is a century-old parallel banking system in India. In this system, the traders send cash generally from one state to another through a person called Angadia that stands for courier.
- **2.**It is by and large used in the jewellery business with Mumbai Surat being the most popular route as they are two ends of the diamond trade. As the cash involved is huge and it is the responsibility of the Angadia to transfer cash from one state to another, they charge a nominal fee. Generally, it is the Gujarati, Marwari and Malbari community that are involved in the business.
- 3. Working The Angadia system works completely on trust as large sums, at times in crores, are involved. Generally, traders have the same Angadias for decades together. Usually, to verify authenticity, the trader will give any Rupee note to the Angadia and provide the number of the note to the recipient. It is only after the recipient confirms the note number that the Angadia will hand over the money to the person.
- **4.**Legality While the Angadia system per se is legal, there hangs a cloud over the activity as it is suspected that a lot of times it is used to transfer unaccounted money. Since the business deals in cash and there is no account maintained for the same, there have been suspicions that it is also used for transfer of black money.

PANRUTI CASHEWS

- **1.**Tamil Nadu Cashew Processors and Exporters Association (TNCPEA) has applied for a Geographical Indication (GI) tag for Panruti cashews. Panruti cashew is mainly found in Tamil Nadu. Though Panruti cashews are slightly small, they have a unique value in the market. **2.**Colloquially known as the **'goldmine' of Cuddalore,** it has a huge demand across India and the world because of the unique taste and quality. - **3.**Apart from Panruti Cashew, 'Panruti Jackfruit' and 'Panruti Cashew Apple' are also famous in Panruti town. The cashew apples from Panruti are also uniquely distinctive. They are round-shaped and bright red in colour.

NATIONAL MEANS-CUM-MERIT SCHOLARSHIP

- 1. The Government has approved the continuation of Central Sector National Means-cum-Merit Scholarship (NMMSS) over the 15th Finance Commission cycle for a period of five years i.e. from 2021-22 to 2025-26. This Scheme will now be implemented with minor modifications in eligibility criteria such as Increasing income ceiling from Rs.5 lakh per annum to Rs.3.5 lakh per annum and Revising the renewal criteria under the scheme.
- **2.**This Central Sector Scheme was launched in 2008 to provide scholarships for meritorious students of classes IX to XII. The scheme is on-boarded on the National Scholarship Portal (NSP) developed by the Ministry of Electronics and Information Technology. This scheme has an objective to award scholarships to meritorious students of economically weaker sections to arrest their drop-out at class VIII and encourage them to continue their education at secondary stage.
- **3.**One lakh fresh scholarships of Rs.12, 000 per annum (Rs.1000 per month) are awarded to selected students of class IX every year. This scholarship will ensure their continuation/renewal in classes X to XII for study in the State Government, Government-aided and Local body schools under the scheme. Selection Students are selected for award of scholarships through the NMMSS selection test conducted by the State/ UT Governments. **4.**Eligibility criteria Students whose parental income from all
- **4.**Eligibility criteria Students whose parental income from all sources is not more than Rs. 3,50,000/- p.a. The student must have minimum of 55 % marks or equivalent grade in Class VII exam for appearing in selection test (relaxable by 5% for SC and

The United States and its allies unveiled more sanctions against Russia on Wednesday over its recognition of two separatist areas in eastern Ukraine, while making clear they were keeping tougher measures in reserve in case of a full-scale invasion by Moscow.

Amid escalating tensions between Ukraine and Russia, warships of Quad countries, France, Myanmar, South Korea and Vietnam and several others will come together at Visakhapatnam later this week for the largest multilateral exercise MILAN, hosted by the Indian Navy. Russia, Iran, Israel and Saudi Arabia among others are participating in the exercise without ships.

In a first, the Indian Air Force (IAF) will deploy the indigenous Light Combat Aircraft (LCA) Tejas for multilateral air exercise 'Cobra Warrior' at Waddington, U.K., which will also see the participation of Air Forces of Belgium, Saudi Arabia, Sweden and the U.S., defence officials said.

The Tamil Nadu government has banned the tourist movement from Kerala through Mulli in Attappady. The government has issued the ban order citing disturbances to animal movements because of tourist vehicles from Kerala.

Railways have begun the installation of hanging solar fence at sensitive forest areas between Kanjikode and Walayar stations. Railway officials said that the Southern Railway was installing hanging solar fence for the first time to prevent elephant movement across the tracks.

ONE CLASS-ONE CHANNEL

1.As part of the education sector initiative, the Union Finance Minister announced an expansion of the 'One Class, One TV channel' program under the PM eVIDYA scheme. **The 'One Class, One TV channel' program will be expanded from current 12 channels to 200 channels. 2.**The expansion has been done in order to enable states to offer supplementary education in regional languages for Classes 1 to 12. The budget also detailed that high quality e-content in all spoken languages will be developed for delivery via internet, mobile phones, televisions, radio and through digital teachers.

3.A competitive mechanism for development of quality e-content by the teachers will also be setup to empower and equip them with digital tools and facilitate better learning outcomes.

PMeVIDYA INITIATIVE

1.In 2020, the PM eVIDYA initiative was launched by the Central government as part of the Aatma Nirbhar Apna Bharat program. PM e-VIDYA unifies all efforts related to digital/online/on-air education to enable multi-mode access to education.

2.It will provide technology-driven education to students during the COVID-19 pandemic, which led to a shutdown of schools. 12 DTH channels were introduced as part of the 'One Class, One TV channel initiative'. Community and radio podcasts for visually and hearing-impaired students were also included under this initiative.

3.Under the PM eVIDYA scheme, two portals were provided. They are, Digital Infrastructure for Knowledge Sharing (DIKSHA) and National Initiative for School Head's and Teacher's Holistic Advancement (NISHTHA).

4.Under the DIKSHA portal, students from classes 1 to 12 were provided with portals which could be accessed with QR codes and contained NCERT, CBSE and NIOS related online books. NISHTHA portal was for teachers in order to help them in training for digital delivery of classes so that the learning outcomes of students could be improved.

NATIONAL OVERSEAS SCHOLARSHIP SCHEME

1. The Central government has said that students applying for the National Overseas Scholarships will no longer be able to avail the grant for courses on Indian culture, heritage, history, social studies on India-based research.

2.The Central Sector Scheme of National Overseas Scholarships was initiated in 1952. This grant is given by the Ministry of Social Justice and Empowerment. It provides an opportunity for low income students belonging to marginalised communities to obtain Masters or PhD degrees. Started only for STEM courses, the scholarships were extended to humanities students in 2012.

3.In all, 100 scholarships are granted to students under the Scheduled Castes (90), Denotified Nomadic and Semi-Nomadic Tribes (6), Landless Agricultural Labourers and Traditional Artisans categories (4). 30% of the awards for each year are earmarked for women candidates. In order to be eligible for scholarship, at least 60% of marks or equivalent grade in the qualifying examination would be required.

4.Eligibility - The age of candidate should not be more than 35 years, as on first day of April of the selection year. [In case of Ph. D courses, the qualifying exam would be Master's Degree and for Master's Degree courses, the qualifying exam would be Bachelor's Degree.]

5.Total family income from all sources shall not exceed Rs. 8.00 lakh per annum in the preceding year. Not more than two children of the same parents/guardians will be eligible for scholarship under the scheme. Implementation agency - Department of Social Justice & Empowerment, Ministry of Social Justice & Empowerment.
